**DRAFT NAMIBIA CIVIL AVIATION REGULATIONS AND TECHNICAL STANDARDS
(2018)**

**VERSIONS AVAILABLE FOR PUBLIC CONSULTATIONS
(INVITATION FOR COMMENTS)**

In terms of section 10 of the Civil Aviation Act, 2016 (Act No. 6 of 2016, 'the Act'), the Namibia Civil Aviation Authority ('the NCAA') must, among others, "conduct oversight of the safety and security of civil aviation in Namibia by... developing and promoting appropriate, clear and concise regulatory requirements and technical aviation safety and security standards", and in this manner also "promoting communication with all interested parties on aviation safety and security".

The Board of the NCAA will seek the consideration of the Minister of Works and Transport, to approve in terms of the Act certain categories of the revised **Namibia Civil Aviation Regulations (NAMCARS)**.

Furthermore, notice is given that the Executive Director of the NCAA intends to issue certain categories of the **Namibia Civil Aviation Technical Standards (NAMCATS)**, in accordance with section 227 of the Act.

The NCAA hereby extends an invitation to the public to submit written comments, or any other appropriate input, on the draft NAMCARS and NAMCATS by the **closing date: (Wednesday) 6th December 2017**.
